Helping Families Navigate the Application Process

Use this guide and follow the steps carefully when applying for a FREE Early Learning & Child Care seat for your child.

Who Can Apply:

- · Residents of Louisiana and Orleans Parish
- Expectant Mothers
- Parent(s) with Children under the age of 5
- Legal Guardians with Children under the age of 5

NOTE:

Not every child is eligible for a free early learning program seat. Eligibility requirements include parental income, age, residency, and categorical eligibility, among other factors.




Family Resource Center:

What Does Categorically Eligible Families Mean:

Families that are categorically eligible do not need to submit proof of income. Families in a temporary living arrangement due to loss of housing or economic hardship (homeless) must verify their status with NOLA-PS. Categorically, eligibility includes:

- Currently receiving SNAP Benefits
- Proof of Housing Instability
- Child Currently Lives in Foster Care



Children with disabilities and those whose home language is not English may be eligible for services but must still qualify to participate in free programs. These children can be served through other funding sources such as Title I, 8(g), and IDEA.

Early Learning Gifted and Talented Enrollment

Free seats are available for eligible gifted and talented children between 3 and 4 years old. To qualify, families must have a current Gifted and Talented IEP approved by the NOLA-PS Office of Child Search and a verified Early Learning & Child Care Application.

FOUR Income Verification Documents Required:

Submit the following documents to prove income status:

- □ Provide all check stubs within the previous 45 days (if paid monthly, provide check stubs within the previous 60 days) for ALL parent(s) and other adult(s) living in the household, including Social Security Income benefits, if applicable, accompanied by all other applicable income documentation or
- ☐ A statement from the Social Security Administration
 verifying that the child listed on the application is a
 recipient of SSI benefits, which must be accompanied
 by two current pay statements or
- ☐ **Official employer letter** stating place of employment, hourly rate of pay & average number of hours worked per week, **or**
- ☐ **Unemployment Benefits** with a Monetary Determination letter from the Workforce Commission **or**
- ☐ Statements of No Income questions will appear on the application for any adult you indicate does not have income Declaration of irregular Employment or Income, if intermittently or self-employed, with no other proof of income to provide; the required fields will appear on the application for any adult who does not receive consistent pay statements each pay period

Calculating Monthly Household Income:

Monthly Household Income is calculated by Gross Monthly Income and the Number of People in the Household.

Click Household Income Chart to view the current eligibility levels.

To qualify for a free early childhood seat, families must upload photos of documents through the online application portal at EnrollNolaPS.com or by delivering documents to a Family Resource Center operated by NOLA Public Schools. You must verify your eligibility to receive a placement.

Once you've chosen your top early learning program options and prepared your documents, it's time to apply! Create an online account, fill in the required information, and add your early learning program choices. Follow the steps to upload the required documents and answer the remaining questions on the application.

After your application is submitted, we will review your documents. If approved, you will be eligible for a seat. If your documents are not approved, we will notify you about any missing information.

Tracking Your Application Status:

ADMISSIONS



You are placed in a seat and/or on the waitlist.

CANCELED

You are not eligible for any free seats, or you have two or more applications in the system or your DOB was wrong, and your child is too old for an EC seat.

STEP FOUR:

How to Accept a Seat and Manage Your Choices

- You will receive notification of placement results in your application portal.
- Use the Enroll NOLA Application Portal to see your results and accept or decline seats.
- Not all families will get a seat, so make sure to check your waitlist status for your school choices in the application portal.
- When a seat becomes available, and you are next on the list, you will get an
 offer via text or email.
- If your contact information changes after you apply, contact a Family Resource Center.
- During the Open Enrollment period, add yourself to waitlists or accept open seats. See <u>Enrollnolaps.com</u> for more information.





What is Main Round Enrollment:

Held once per year, this is when all publicly funded seats become available for all eligible children. If your application is approved and your child is eligible for a free seat, your choices will be included in the match and eligible to be waitlisted.

What is Open Enrollment:

The period outside of Main Round Enrollment.

Applications are accepted for publicly funded seats, but placement is not guaranteed. (Students added to the waitlist behind main round applicants.)
