Change of Circumstance: Student Residence Change	Student has moved to a different residence. The distance from home to school is at least two miles further away at the new residence than the prior residence.	Proof of new residency in the form of a bill from a company that shows your address (such as light bill, water bill, mortgage/lease, property taxes)	Family	Personal letters or correspondence from individuals will not be accepted. Bills that are not tied to the residence such as car insurance.	Google Maps route (distance and travel time) from prior and current residence to school at the time of the school commute.
Change of Circumstance: Student Custody Change	Student is in the custody of a different parent/guardian and is unable to continue attending current school due to the change.	Court-issued documentation signed by a judge that shows temporary or permanent custody order.	Family	Notarized letters confirming custody.	
Change of Circumstance: Caregiver Change	Student's caregiver has experienced a change in circumstances that impacts the student's transportation or childcare, and the student is unable to continue attending current school.	Documentation showing change in childcare. Documentation options vary widely based on the circumstances. Examples could include a paystub from a new job or a record of a change in an older sibling's enrollment.	Family		
Change of Circumstance: Transportation Change	Transportation to/from school provided by the school, or family has changed or is no longer available, preventing the student from regularly attending school.	Documentation showing the change in transportation or proof that bus ride is more than 90 minutes, one-way. If a change in school bus routes/availability, include the old bus route information and new bus route information.	Family and/or School
